 - i. the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (including all amendments, modification or substitution thereof), SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018 (including all amendments, modifications or substitutions thereof) and other applicable regulations /guidelines/circulars as may be issued or amended by SEBI from time to time.
 - ii. the relevant byelaws / regulations / circulars / notices / guidelines as may be issued by the Exchange from time to time.
 - iii. such other directions, requirements and conditions as may be imposed by SEBI / Exchange from time to time.
3. That it shall pay registration and such other fees / fines as may be specified / levied by the Exchange from time to time within the prescribed period.
4. That it shall keep intimated the Exchange about change in any information/ details of the Social Enterprise.

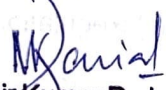
