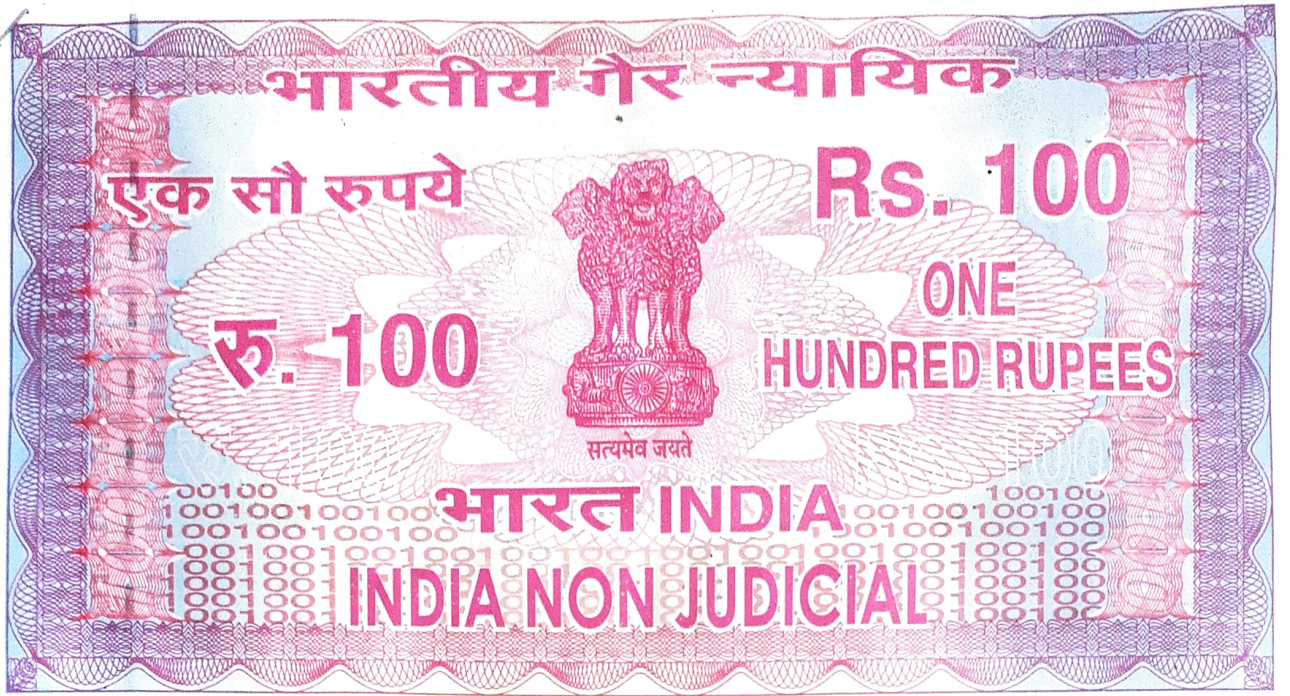

3. That it shall pay listing and such other fees / fines as may be specified / levied by the Exchange from time to time within the prescribed period.



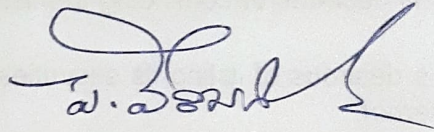
